2. This warranty is in any circumstance limited to (at the option of Viking Roofspec) either.
 - providing replacement new materials for the defective materials
 - providing a refund for the defective materials, the amount of which shall not exceed the original purchase price of the product(s).

6. Viking Roofspec shall not be liable under this warranty for any consequential, indirect, or special loss or damage of any kind whatsoever, or loss of profits, whether under contract, tort or otherwise.
7. Viking Roofspec does not give any warranty as to the suitability of any installer and will not, in any circumstances be liable for the actions of any installer.
8. Viking Buzon Screw-Jack Pedestals are not warranted against, and Viking Roofspec shall not be liable for damage caused by:
 - mechanical damage;
 - chemical or substance.
 - any shifting or altering of the building after installation;
 - the failure of other Building components.
 - the lack of adequate drainage.
 - environmental factors including, pollutants and biological agents contaminated
 - water or contaminated earth.
 - accident or intentional or negligent acts, misuse, abuse, vandalism or civil
 - disobedience or the like; or
 - Acts of God which include, but are not limited to, acts of nature without human intervention, such as earthquakes, storms, floods, and explosions.

9. Should any material defect require remedy under the terms of this warranty, Viking Roofspec must be notified in writing within fourteen (14) days of discovery and any unused defective material must be returned to Viking Roofspec. By notifying Viking Roofspec you authorise Viking Roofspec to investigate the warranty claim to assess whether it falls within the terms of this warranty. Should our investigation of the claim find that the cause is outside the terms of this warranty, then you acknowledge and agree that Viking Roofspec may charge you its reasonable investigation costs. You agree to provide Viking Roofspec free access to any applied materials in order to investigate under this warranty during normal business hours.
10. Nothing in this warranty shall require Viking Roofspec to contribute to any cost of labour or material repair, or to shift any earth, hardfill, structure, fixtures, plant, equipment, flashings, or other items so as to allow access for any repair or replacement. Neither shall Viking Roofspec be liable for any costs involved in such shifting or reinstallation.
11. This Warranty represents the limit of Viking Roofspec's liability for Viking Buzon Screw-Jack Pedestals. All other warranties, express or implied, are hereby excluded to the maximum extent permitted by applicable law.
12. Notwithstanding any other provisions of this warranty, nothing in this warranty is intended to limit any condition, warranty, right or remedy available under or imposed by any applicable legislation including, for the avoidance of doubt but without limitation, the Building Act 2004, the Fair-Trading Act 1986 and the Consumer Guarantees Act 1993) except to the extent permitted by such legislation.
